The precise schedule of events will be determined after the close of deadline but will not be final until the day before competition begins. More details schedule posted after the Team Managers Meeting.

Participation:

The Host country may enter a maximum of 64 fencers, while other countries are limited to a maximum of 20 fencers. Fencers from other continents are welcome and will be subjected to the same conditions to participate. All fencers must endorsed by their federations.





All participating fencers must be born in the year 2008 to 2011 and must have a valid FCA License for the season 2024/2025, issued by the FCA.

Cadet fencers with valid FCA license interested to participate in any scheduled cadet competition in the season must register through the FCA Portal System at least one week before the start of competition (28/11/2024). The host country shall not allow participation of any fencer without valid FCA License and not registered with the FCA Portal System.

Equipment/Uniforms:

Fencers must use standard FIE uniforms/equipment (800 NW for clothing, 1600 NW masks, 800 NW under garment/plastron, FIE homologated blades). No name on the back of the fencer's clothing is required Uniforms with markings other than of the official federation (such as schools, clubs) may be allowed.

Fees:

The competition entry fee is US\$ 40 per person per individual event, US\$ 60 per team should be paid to the Organizer

Fees

- Cadet fencers must register in the FCA website to apply for such license and pay an annual fee of US\$25 to the FCA.
- The competition entry fee is US\$40.00 per person per individual event to be paid to the Organizer.
- The competition entry fee is US\$60.00 per team event to be paid to the Organizer.
- Payment of entry fees are to be paid in cash by 3rd December 2024 after the Team Managers' Meeting.

Points and Ranking:

The points (earned from the best 3 cups competitions plus the zonal cadet championships) will be counted into the Ranking. Seeding of the fencers in every cadet competition (any cups and the zonal championships) will consider the latest Asian ranking of the cadet fencer before such competition.

For competitions participated in by at least 30 fencers from at least 5 Asian/Oceania countries, the following points will be awarded:

1st Place = 32 points
2nd Place = 26 points
3rd Place = 20 points
5th Place = 16 points
6th Place = 14 points
7th Place = 12 points
8th Place = 10 points
9th to 12th Place = 9 points
17th to 16th = 8 points
17th to 24th = 6 points
25th to 32nd = 4 points
33rd to 64th = 2 points
65th to 128th = 1 point

For scheduled competitions with less than 30 fencers or at least 5 Asian/Oceania countries, ONLY 50% of the points will be awarded.

In all competitions, fencers who are eliminated from the round of pools, will receive zero (0) point.

FCA shall be responsible for tabulating the overall Asian cadet ranking based on the points awarded during the competition.

Referees/Officials:

Participating countries must be accompanied by qualified referees based on the following quota:

1 – 4 fencers no referee required

5-9 fencers, 1 referee

10-15 fencers, 2 referees

16 - 20 fencers, 3 referees

Non respect of referee quota is sanctioned by US\$500 for every missing referee.

Qualified referees are those with good national or international level qualification and experience.

The Host country shall provide at least two (2) FIE licensed referees coming from different countries. FCA shall designate one official Referee Delegate from among the participating referees





System and Formula of Competition

Generally, FIE technical and competition rules are to be respected. Formula of competition:

- With no more than 30 fencers, two rounds of pools followed by Direct Elimination table with classification matches from T-16
- With more than 30 fencers, two rounds of pools followed by Direct Elimination
- With more than 50 fencers, one round of pools followed by Direct Elimination
- When there are two rounds of pools, the results of both rounds must be considered in preparing the DE table, at least 10% and a maximum of 20% of the competitors should be eliminated

All competitions should use the systems of Fencing Time, Engarde or their equivalent.

Competition Method

The fencing competition shall be conducted in accordance with the current Statutes and Rules of the FIE. In case of disagreement in the interpretation of the Rules, the latest English version shall prevail. The Directoire Technique shall deal with any unforeseen incidents not covered by the Rules.

Awards:

Organizers shall provide all participants with a Certificate of Participation and a Diploma to the top 8 placers in each event. The top 4 placers in each event shall also be provided with medals by the FCA.

Awards

Organizers shall provide a Diploma to the top 8 placers in each individual event and top 4 in each team event.

Individual Event, One (1) gold, one (1) silver, and two (2) bronze medals to the top four (4) fencers and diplomas to the top eight (8) fencers.





Team Event, four (4) gold medals for the champion team, four (4) silver medals for the second placed team, and two (2) sets of four (4) bronze medals for the two losing teams in the semifinals

VISA REGULATIONS FOR SOME COUNTRIES

- 1. A bilateral visa-free regime has been established with Kyrgyzstan (up to 60 days), Tajikistan (up to 30 days), Azerbaijan, Armenia, Belarus, Georgia, Kazakhstan, Moldova, Russia and Ukraine.
- 2. A visa-free regime is introduced for 30 days period for citizens of Andorra Principality, Australian Union, Austrian Republic, Argentine Republic, Bosnia and Herzegovina, Brunei Darussalam State, Canada, Czech Republic, Federative Republic of Brazil, Federal Republic of Germany, Finland Republic, French Republic, Grand Duchy of Luxembourg, Hungary, Greek Republic, Israel, Indonesia, Ireland, Iceland, Italian Republic, Liechtenstein, Principality of Monaco, the Kingdom of Belgium, the Kingdom of Denmark, the Kingdom of Spain, the Kingdom of the Netherlands, the Kingdom of Norway, the Kingdom of Sweden, the Republic of Latvia, the Republic of Lithuania, Malaysia, Mongolia, New Zealand, Portugal Republic, Republic of Bulgaria, Republic of Cyprus, Republic of Korea, Republic of Malta, Mexico, Republic of Poland, Republic of San Marino, Republic of Serbia, Singapore, Republic of Slovenia, Republic of Croatia, Republic of Chile, Romania, Slovak Republic, Republic of Turkey, Swiss Confederation, Republic of Estonia, Japan, UAE, United Kingdom of Great Britain and Northern Ireland, Vatican.

The visa-free regime applies to citizens of these countries, holders of all categories of passports (diplomatic, service and civil) planning to visit the Republic of Uzbekistan for up to 30 days, regardless of the purpose of their trip. In order to enter the country, a person must have a valid national passport or another substitute document used for travel to foreign countries.





The visa-free regime does not apply to stateless persons permanently residing in the territories of these countries.
